This is a special permit application to construct a duplex residence at 1120 Federal Street in town. It is properly zoned for this purpose. The Board will send it back to the ZBA indicating they have no concerns at this time; however, ask that the ZBA pay attention to concerns that other boards, committees or abutters may have.

9) **Questions from the Press:** None.


